I've had the pleasure of knowing Adam Richardson for almost my entire clinical career. He is outstanding and absolutely deserving of this award.

Adam currently works as a Senior Nurse Practitioner II in the Adult Emergency Department at the University of Maryland Medical Center, where he additionally serves as the NP Education Leader. Clinically he is outstanding, and undoubtedly has one of the highest PPH counts in the department (if not THE highest). He certainly has an outsized impact on our flow metrics with his elite room-to-provider times and department leading provider-to-disposition times. But Adam's contributions go well beyond just his excellent clinical care and decision-making, and that's why I am adamant he is deserving of this recognition.
